Ocean County College FY 2013 Budget Request

The Ocean County College FY 2013 Budget will be presented to the Board of Trustees for approval at Monday's meeting. The proposed budget includes a \$4 increase in tuition, from \$94 per credit to \$98, as well as small increases in college, course, and technology fees, effective with the fall 2012 semester. Tuition and fees have remained stable for several years; the last increase was in 2008.

The increased tuition is necessary to present a balanced budget given the following expectations for revenue:

- **State funding** is anticipated to remain at the **2011-2012 level**.
- County funding is anticipated to remain at the 2011-2012 level.
- **On-campus** student **enrollment** is anticipated to **decline slightly**, although the number of **distance learning** students will most likely **increase**.

Following approval by the Board of Trustees, the budget will be presented to the Ocean County College Board of School Estimate at a meeting to be scheduled in March. In keeping with New Jersey Statute, the Board of School Estimate is comprised of three freeholders and two trustees. This year's Board of School Estimate members are Freeholders John C. Bartlett, Jr., James F. Lacey, and Gerry P. Little and Board Chair Van Thulin and Board Treasurer Jerry Dasti. Board Secretary Stephan Leone serves as the Secretary of the Board of School Estimate.

Middle States Commission on Higher Education

On Monday, January 23, Dr. Ellie Fogarty, Middle States Commission on Higher Education's liaison to Ocean County College, visited the campus in preparation for the College's self-study process, which will result in our 2014 report to the Commission. The purpose of her visit was to



reinforce the **partnership** between **OCC** and the **Commission** by **learning** more about the **College**, providing **expertise** on the **Commission's expectations**, and discussing the College's **self-study process**.

Dr. Fogarty had a **full day** of **meetings** with **me**, the **Self-Study Steering Committee**, **team leaders** and **members**, several **trustees**, **faculty**, **staff**, and our **Self-Study Co-Chairs**, **Ms. Janet Hubbs** and **Dr. Carolyn Lafferty**. **Dr. Fogarty** provided some **valuable insight** into the **accreditation process**, and I believe she was **impressed** with the College's **commitment** to the **self-study** as well as the **progress** already made on it.

Legislative Visits

Every February for a number of years, I have traveled to Washington, D.C., to visit with state and national legislators. Mr. David Wolfe, Special Assistant to the President and 10th District Assemblyman, has scheduled times on Monday, February 6, and Tuesday, February 7, for us to meet with Congressmen Chris Smith and Jon Runyan to discuss several important issues that affect the College and our students.

One of the issues **Mr. Wolfe** and **I** will be **discussing** with the **legislators** is the **effect** the **mandated cuts** to **Federal financial aid programs** will have on our **students** and all other **community college students**. **Legislation** signed in **December negatively** impacts **student aid programs** authorized under **Title IV of the Higher Education Act of 1965** as follows:

- Elimination of the Ability to Benefit options
- ♦ Reduction of the Auto-Zero income threshold from \$30,000 to \$23,000
- Reduction of student income protection allowances
- Elimination of year-round Pell grants
- Reduced lifetime Pell eligibility from 18 semesters to 12 semesters

After our visit, I will **inform you** of the **outcome** of our discussions.

The Viking Women's Program has the most points of any school (53) from the fall semester, based on team rankings at the National Junior College Athletic Association Championships. This past fall, four OCC teams competed in their respective national championships. The teams finished as follows:

Women's Soccer – 3rd place Women's Cross Country – 3rd place Women's Tennis – 4th place Men's Cross Country – 6th place

NATYCAA is the professional organization of two-year college athletic administrators, and membership is open to all two-year institutions from throughout the country. NATYCAA includes 11 professional

associations and is administered by the National Association of Collegiate Directors of Athletics.

The NATYCAA Cup program began in 2004 to recognize excellence in two-year college athletics. Standings are ranked twice during the academic year; mid-year rankings occur in January and final standings are in June.
