## Energy Reduction/Savings

In the **spring of 2009**, Ocean County College made a **commitment** to a comprehensive **energy reduction project**. The project included **many buildings** on campus with **multiple strategies** to **reduce** overall **energy usage**. New Jersey **State law** allowed a selection of **energy conservation measures** that would **self-fund** over a **ten-year period**; **OCC's project** will **self-fund** sooner, within **seven years**.

The **energy reduction project** resulted in **1.8 million kilowatt-hours** of **electricity savings**, **47,000 therms** of **natural gas savings**, and an **overall energy cost savings** of **\$346,000** in the **first full year** of operation. With rising energy costs, the **ten-year energy savings** should **exceed \$4,000,000**.

The **environmental impact** of the project is a **carbon dioxide (CO<sub>2</sub>) greenhouse gas savings** of **1.6 tons**, which is **equivalent to planting 7,852 trees** or the removal of **275 cars** from our roads. In addition, several buildings included in the project qualified to **participate** in **New Jersey's Pay for Performance (P4P) incentive program**. The **incentive payments** totaled **\$383,222**; this **incentive money** will be used at OCC to pursue **greater savings** with **combined heat and power projects** (with a **potential additional \$1,000,000** in **P4P energy incentive funds**).

In our **current climate** of **high energy costs**, **dwindling supplies**, and **environmental concerns**, **OCC is leading the way** among New Jersey colleges in securing a **greener, more energy efficient future**.

I have asked **Mr. Ken Olsen, Director of Facilities and Operations**, to provide **additional details** about our **innovative** and **successful energy savings program** at **Monday's meeting**.

## NJ STARS Program

The New Jersey Student Tuition Assistance Reward Scholarship (NJ STARS) Program for community college students and the NJ STARS II Program for juniors and seniors at New Jersey's public colleges and universities will remain unchanged for 2011-2012.

NJ STARS will provide full tuition community college scholarships for students who graduate high school in the top 15 percent of their class. NJ STARS II will provide \$6,000 per year tuition scholarships to NJ STARS students who earn their associate degrees with grade point averages between 3.25 and 3.49 and transfer to New Jersey public colleges to complete their baccalaureate degrees. For NJ STARS students who complete their associate degrees at community colleges with grade point averages between 3.5 and 4.0, NJ STARS II will provide \$7,000 per year tuition scholarships.

## Athletics

Ms. Ilene Cohen, Director of Athletics, will be at Monday's Board meeting with two students who recently received well deserved recognition for their outstanding accomplishments:

- ◆ **David Kalash** – As reported to you last month, David, a member of OCC's baseball team, was recognized for the second year in a row by Rawlings as a Gold Glove Award Recipient for his excellent play in the outfield. He did not commit an error and had a perfect 1.000 fielding percentage during the baseball season.

The Rawlings Gold Glove Award is the benchmark of excellence and performance on the diamond in Major League Baseball and is a most prestigious award to receive.

- ◆ **Dan Wroblewski** – Dan was just recently selected to receive the National Junior College Athletic Association's Region XIX Robert Zifchak Male Scholar Athlete Award for 2010-2011. As a goalkeeper on the men's soccer team, Dan only allowed 32 goals in his 39 game career at OCC and posted 19 career shutouts. He was named to All-Region and All-Conference teams, was on the NJCAA Academic Team, and has been on the President's Honors List every semester he has been at OCC.

The Robert Zifchak Award is given annually to one male student athlete in Region XIX who has earned at least a 3.5 grade point average, has received recognition at the Regional, Conference, or National level, and has contributed to his College campus.

In addition, we are very proud to announce that OCC's women's basketball team was honored as the 2010-2011 Region XIX Team Champions of Character recipient. This award recognizes a Region
