Ocean County College Athletics

The College was recently informed by the **National Junior College Athletic Association (NJCAA)** that the **OCC Women's Cross Country Team** not only **won the national championships** but also **ranked #1 academically** in the country with a **team grade point average of 3.73**. The **Men's Soccer Team** **ranked #2** in the country with a **team grade point average of 3.02**. This **academic excellence is outstanding** and is a **reflection** of the **OCC Athletic Program's expectations** from and **support** to its student-athletes.

The **2010 NJCAA Swimming and Diving Championships** were held from **March 2nd to March 6th** in **Fort Pierce, Florida**. The **men's team** finished in **second place** in the **non-scholarship division** and the **women's team** finished **fourth**.

The **OCC swimmers** made quite an **impact** at the **national championships**. **Five new Ocean County College records** were set:

- ◆ In the **50 freestyle relay**, **Billy deRouville** set a **record** by besting his previous school record of 22.08 with a time of **21.99**.
- ◆ In the **100 freestyle relay**, he set another **record** with a time of **47.41**, beating his previous record of 48.28.
- ◆ In the **200 freestyle relay**, Billy **broke a school record** that has been in place since 1977. He swam with a time of **1:47.01**; the previous record was 1:47.52.
- ◆ The **200 freestyle relay team** of **Jordan Centofanti, Rob Coates, Brian Mahoney, and Billy deRouville** set an **OCC record** with a time of **1:28.44**, besting the previous record of 1:29.06 which was set last year.
- ◆ The **400 freestyle relay team** of **Jordan Centofanti, Rob Coates, Brian Mahoney, and Billy deRouville** set the **record** with a time of **3:17.06**. The previous record was set last year with a time of 3:19.64.

At Monday's meeting, **Mr. Don Doran, Vice President of Student Affairs**, will **introduce Ms. Jaclyn Rodemann, Director of Recruitment and Admissions, and Ms. Megan Springsted, Recruitment Coordinator**, who will **share with you an overview of recruitment activities**.

The **goal of the OCC Security Department** is to provide a **safe and secure environment** for the **campus community**. To **accomplish this goal**, the Security Department has **implemented several new programs and initiatives**, some of which include:

- ◆ An **emergency loudspeaker system** was recently **purchased and deployed** that is capable of sending **clear and concise messages** to the entire **college campus**. The loudspeaker system proved to be **quite effective** when it was utilized during a recent **snow storm**. Eventually, **all buildings** will be capable of **receiving messages** via a **public address system**.

- ◆ The **closed circuit TV system** has been **enhanced** to provide **coverage** in **areas** that were previously considered **vulnerable**.
- ◆ With **assistance** from **College Relations**, the **security webpage** has been **improved** to now include an **anonymous “crime tip” line**.
- ◆ The **visibility** of **security** on campus has been **improved** with an **increased presence** in **high traffic areas** as well as at **athletic events**. **Security uniforms** have been **upgraded** for a more **professional appearance**, a **new look** that has been **favorably received** by **security officers** themselves and the **campus community**.
- ◆ A new **student security team** has been **established** on campus. The **Community Service Officer (CSO) program** allows select **students** to work closely with the College's **security force**, receiving **training** in areas such as **patrol tactics** and **medical emergencies**. The **CSO's** wear **bright yellow shirts** as they **patrol** the campus, and they have become an **extension** of our **eyes and ears**.
- ◆ A **Ford Escape Hybrid** and a **Vantage Electric truck** have been **added** to the **Security fleet**. Aside from the obvious **cost savings** associated with these **new vehicles**, they have been a **public relations success** as numerous students and staff have made **positive comments** on our efforts to **“go green.”**
- ◆ **Seven Automated External Defibrillators (AED's)** have been **installed** throughout the campus in the event of **cardiac emergency**, and approximately **30 faculty** and **staff members** have been **trained** in **CPR** and **AED**.

I have asked **Mr. Bob Kumpf, Director of College Security**, to talk with you at **Monday's meeting** about all of these **new initiatives**. Since his **arrival** at the **campus** last **August**, **Mr. Kumpf** has made **exceptional progress** in ensuring the **safety** of our **students**, our **staff**, and our **campus facilities**.

2010 Best Practices Conference

The **New Jersey Council of County Colleges 2010 Best Practices Conference**, **“New Directions for Turbulent Times,”** is scheduled for **Friday, April 23rd**, from **8:00 a.m. to 3:15 p.m.** This year, the event is being **hosted** by **Brookdale Community College** in its **Warner Student Life Center** in **Lincroft**.

Media Interview

NJN, **New Jersey Public Television and Radio**, visited the Ocean County College **campus** to **interview** **Ms. Sara Winchester**, **Vice President of Finance**, to garner the College's **reaction** to the Governor's **announcement** of **reduced State funding** for the remainder of **FY 2010**.

Ms. Winchester discussed **OCC's plans** to implement **internal cost-saving measures** to ensure the College remains **affordable** for **students**, among which are a **selective freeze** on **hiring**, **deferral** of some **major capital projects**, **restricted travel**, and additional **administrative reorganization**. She emphasized that the **loss in State aid** will **not affect** the **quality** of **education** OCC provides.
