Ocean County College Swim Teams – National Winners

For the **first time** in the **history** of the **college**, the **men's and women's swimming teams won the Non-Scholarship Division of the National Junior College Athletic Association (NJCAA) Swimming and Diving Championships.** They accomplished this **outstanding achievement** at **Erie Community College in Buffalo, New York**, during the **competition** which took place from **Wednesday to Saturday, March 4th to 7th.**

Our swimmers were **extremely successful**, with many achieving **personal best times** and **best times** for the **season**:

The **League for Innovation in the Community College** is an **international organization** dedicated to **servicing community colleges** through **conferences and**

institutes, research, publications, initiatives, and Web resources. Each year the League honors outstanding innovations which have been recognized by member institutions as **Innovations of the Year**. These innovations represent **capstone achievements** and the **continuing renewal** of the **spirit of innovation** and **experimentation**.

This year, **Thomas Lesniak, Adjunct Assistant Professor of Science**, has received **Ocean County College's Innovator of the Year Award** for his **development and implementation** of multiple internal and external **crime scene locations** for the **Criminal Justice Program**. The crime scenes **integrated evidence** into several scenarios requiring students to demonstrate **critical thinking** and **analytical deduction**. The multiple scenes involved the **collection of furniture, clothing, and weapons** (nonfunctioning). In addition to the critical thinking and analytical deduction activities, the students had the **experience** of a **life-like evidence collection**, including **photographic evidence**. Professor Lesniak's efforts were **coordinated** with members of the **Criminal Justice faculty**.

Congratulations to Professor Lesniak on this **well-deserved recognition**, which will be **acknowledged** on the **League for Innovation website**.

Bookstore Rewards Program

The **Ocean County College Bookstore** recently **implemented** a new **rewards program** to allow our students to **earn Viking Bucks**, which can be **redeemed** on **future purchases** in the Bookstore.

This **Viking Bucks rewards program** works much like the **major credit cards** wherein **points** can be **used** to **purchase various items**, such as airline tickets, merchandise, or gift cards. The student earns **one Viking Buck** for **every dollar spent** at the Bookstore. These **Viking Bucks** can be **converted** to **Bookstore gift cards** for **future purchases** of **books, classroom supplies, clothing, or other incidentals**. The only **exceptions** for the use of Viking Bucks are **nursing uniforms** and **computer equipment**.

This is a **wonderful opportunity** for our **students** to **save money** on **textbooks**, the prices of which continually increase. This program is also **available** to **college staff**.

Mathematics Awareness Month

Since **1986**, **Mathematics Awareness Month** is recognized in **April** each year to increase public **understanding of** and **appreciation for mathematics**. It is **sponsored by** the **Joint Policy Board for Mathematics**, which is a **collaborative effort** of the **American Mathematical Society**, **American Statistical Association**, **Mathematical Association of America**, and **Society for Industrial and Applied Mathematics**.

The **theme** this year is **Mathematics and Climate** in recognition of one of the most **important challenges** of our time, **modeling global climate**. Some of the **fundamental questions** researchers are currently **addressing** are:

- ◆ How long will the summer **Arctic sea ice pack survive**?
- ◆ Are **hurricanes** and other **severe weather events** getting **stronger**?
- ◆ How much will **sea level rise** as **ice sheets melt**?
- ◆ How do **human activities** affect **climate change**?
- ◆ How is **global climate monitored**?

Calculus, **differential equations**, **numerical analysis**, **probability**, and **statistics** are just some of the areas of mathematics used to **understand** the **oceans**, **atmosphere**, and **polar ice caps** as well as the **complex interactions** among these **vast systems**. **Analyzing feedback effects** is a **crucial component** of **global climate modeling** and often a **significant factor** in **long-term predictions**.

It is **respectfully requested** that the Board **adopt** a **resolution** proclaiming **April** as **Mathematics Awareness Month** at **Ocean County College** to remind the college community of the **importance** of **mathematics** in our **daily lives**.

National Poetry Month

National Poetry Month was **established** in **1996** by the **Academy of American Poets** as a **month-long**, **national celebration** of poetry. The **goals** of **National Poetry Month** are to:

- Highlight the **extraordinary legacy** and **ongoing achievement** of **American poets**
- Introduce more Americans to the **pleasures of reading poetry**
- **Bring** poets and poetry to the **public** in **immediate** and **innovative ways**
- Make poetry a more **important part** of the **school curriculum**
- **Increase the attention** paid to poetry by **national** and **local media**
- Encourage increased **publication, distribution, and sales** of **poetry books**
- Increase **public** and **private philanthropic support** for poets and poetry

A **number of events** are planned to **celebrate National Poetry Month** at Ocean County College, including **visiting poets**, a **film series**, an **"open mike" poetry session** for students, and student **workshops** for **creative writing**.

I respectfully request that a **resolution be adopted** by the Board to **proclaim** the month of **April** as **Poetry Month** at **Ocean County College** to **encourage** the **study of poetry** by our **students** and **participation** in the **various events** offered on campus to celebrate **National Poetry Month**.

Commendation

The most recent **essay co-written** by **Dr. Martin Novelli, Dean of Humanities, Fine Arts, and Media Studies**, and **Dr. Frank Wetta, Professor of History at Kean University**, was **published** in a collection, **Why We Fought: America's Wars in Film and History (University of Kentucky Press, 2008)**. Their essay is titled **"On Telling the Truth about War: World War II and Hollywood's Moral Fiction, 1945 - 1956."**

Why We Fought: America's Wars in Film and History was named by **CHOICE magazine** as one of the **top 15 books on film** published in **2008**. It has also won the **Ray and Pat Browne Award** for the **best edited collection** in **popular and American Culture Studies** for **2008**. An entire session at the **January 2009 meeting** of the **American Historical Association** in **New York City** was devoted to the **book**.
