Minutes

November 3, 2014

The regularly scheduled monthly meeting of the Ocean County College Board of Trustees was called to order at 12:43 p.m. on Monday, November 3, 2014, by Mr. Carl V. Thulin, Chair, in the Boardroom of the Administration Building on the College campus.

Call to Order

The announcement of public meeting was made by Mrs. Connie Bello in compliance with the Open Public Meetings Act of 1975. Notice of this meeting was publicized through a resolution adopted at the November 2013 reorganization meeting and distributed as required by law.

- An additional \$2,504.73, for a maximum total of \$463,030.57, to Dimension Data, Inc., Edison, New Jersey, for additional hardware and software for use as part of the upgrade to Cisco Voice Over IP equipment and the integration of video conferencing at Ocean County College (contract originally awarded at the May 27, 2014, Board meeting).

- An additional \$15,000, for a maximum total of \$59,065, to Vertical V Northeast, Inc., Rahway, New Jersey, for additional construction testing services for the new Student Center at Ocean County College (contract originally awarded at the November 4, 2013, Board meeting).
- An additional \$20,000, for a maximum of \$43,000, to Deterrent Technologies, Ocean Township, New Jersey, for time and material for any parts and labor for CCTV, access control, and card readers not covered by warranty, and the replacement of cameras, gate operators and arms, and access control to doors as part of the second year of a two-year agreement for security access control services at Ocean County College (contract originally awarded at the August 25, 2014, Board meeting).
- An additional \$157,679, for a maximum of \$777,629, to Kimmel Bogrette Architecture + Site, Conshohocken, Pennsylvania, for a change order for relocation of the hot water plant from the Instructional Building to the combined heat and power plant as part of the architectural and engineering services for the Instructional Building renovations at Ocean County College (contract originally awarded at the September 23, 2013, Board meeting).
- An additional \$159,891, for a maximum of \$502,817, to Ellucian Company, LP, Fairfax, Virginia, for additional fees for instructional technology support, administrative system services, additional staffing, and ecommerce annual volume fee from July 1, 2014, to June 30, 2015, as part of the renewal of the annual licensing and maintenance agreement for Colleague/Datatel administrative programs at Ocean County College (contract originally awarded at the July 25, 2014, Board meeting).
- ➤ The Board rescinded \$1,599.32 of the \$14,086.32 contract awarded to American Medical Contract Depot, King of Prussia, Pennsylvania, at the August 25, 2014, Board meeting, due Rescinded to incorrect bid submissions by the vendor as follows:

- An \$824,450 four-year award from the U.S. Department of Labor, Employment, and Training Administration to partner in a Trade Adjustment Assistance Community College and Career Training (TAACCCT) consortium led by Bergen Community College to develop new programs in Patient Care Technician and Holistic Health and Wellness programs. Project managers: Dr. Jianping Wang, Vice President of Academic Affairs; Ms. Allison King, Vice President of e-Learning/Enterprise Initiatives; and Ms. Patricia Fenn, Assistant Vice President of Continuing and Professional Education and Workforce Development. Funding period: October 1, 2014, through September 30, 2018.
- A \$511,891 three-year award from the U.S. Department of Education, Undergraduate International Studies and Foreign Language Program, to provide funding to establish a Middle East Center, develop a Middle East Studies certificate, and integrate Middle East studies into OCC courses in multiple disciplines as well as to support a Middle East Studies Specialist for the teaching and administrative activities of the Center, with OCC serving as the lead institution in a consortium with AMIDEAST and Kean University. Project manager: Dr. Maysa Hayward, Dean of Instructional Outreach. Funding period: October 1, 2014, through September 30, 2017.

Upon unanimous roll call vote, the Board accepted the Buildings and Grounds Committee Report for November 3, 2014. Mr. Matthew Kennedy, Assistant Vice President of Facilities and Construction Management, reported that a third access road, which will run from the OCC campus to Bay Avenue, was approved by the New Jersey State House Commission at its October 23 meeting. Dr. Larson noted the extraordinary presentation made by Freeholder John C. Bartlett, Jr., to the commissioners detailing the need for the additional roadway. Mrs. Novak, as Chair of the Buildings and Grounds Committee, expressed her apprecitation to Dr. Larson, Freeholder Bartlett, and all others involved for their persistence as approval was sought.

Commendations/Presentations

Ms. Ilene Cohen, Executive Director of Athletics, and Mr. A.J. Trump, Director of Athletics, summarized the achievements of the fall semester sports. Several athletes from the soccer, volleyball, and cross country teams accompanied Ms. Cohen and Mr. Trump and were introduced to the trustees.

Commendations

- ♦ Cross Country The women's cross country team earned its fourth Region XIX title in six years. The men's team finished its season in fourth place.
- ♦ Soccer The women's soccer team won the Region XIX Championship and earned a spot in the NJCAA National Tournament that will be hosted by OCC from Wednesday, November 12, to Sunday, November 16. The event will bring eight of the best women's soccer teams from around the country to OCC for the tournament.
- ♦ Women's Volleyball The women's volleyball team finished its first season as the Garden State Athletic Conference champion and the Region XIX runner-up. The coaching staff of Brett Kollman, Head Coach, and Jen Kelleman, Assistant Coach, were named the Garden State Athletic Conference Coaching Staff of the Year for their undefeated matches in the conference.

Dr. Don Norris and Dr. Tim Gilmour, Strategic Initiatives, Inc., reported on the significant progress that is being made by the Guiding Coalition and the Strategic Action Teams toward ensuring Ocean County College's success as it moves into the future. They reviewed their status report that had been distributed with the President's Report. Drs. Norris and Gilmour

are extraordinarily pleased with the work of the strategy teams, whose reports will be incorporated into a single document that will be discussed at the Board's December 16 Retreat. The trustees thanked Dr. Norris and Dr. Gilmour for their leadership on this initiative and said they are looking forward to reading the final report.

President's Report

Dr. Jianping Wang, Vice President of Academic Affairs, reported on the \$824,450 four-year grant award that OCC received from the U.S. Department of Labor, Employment, and Training Administration to partner in a Trade Adjustment Assistance Community College and Career Training (TAACCCT) program.

President's Report

The partnership will be led by Bergen Community College and includes OCC and ten other New Jersey community colleges, 20 employers, and 10 local Workforce Investment Boards to create a New Jersey Health Professional Pathways to Regional Excellence Project Consortium. As part of the consortium, OCC will establish credit Patient Care Technician certificate and degree programs as well as Holistic Health and Wellness credit degree and certificate programs and a non-credit certificate program.

The project will be overseen and facilitated by Dr. Wang; Dr. Lisa DiBisceglie, Associate Vice President of Academic Affairs; Ms. Allison King, Vice President of e-Learning and Enterprise Initiatives; Ms. Patricia Fenn, Assistant Vice President of Continuing and Professional Education and Workforce Development; Ms. Kathy Caro, Administrator of Nursing and Allied Health; and Ms. Mary Ellen Rada, Lecturer II in Anatomy.

Dr. Maysa Hayward, Dean of Instructional Outreach, reported that Ocean County College has been awarded a three-year \$599,608 grant from the U.S. Department of Education, Undergraduate International Studies and Foreign Language Program, to support an OCC Middle East Center. Dr. Hayward will serve as the project manager, and the Center will be housed within the Ocean Global Institute. This highly competitive grant is very rarely awarded to first-time applicants.

OCC will be working in collaboration with Kean University, Brigham Young University, and the research and educational organization AMIDEAST on certain parts of the grant. Activities supported by the grant will begin this fall semester.

Dr. Larson expressed appreciation to Dr. Hayward and Ms. Sharla Trimm, Ellucian's Senior Grant Consultant, for their efforts in organizing the grant application that led to this very successful outcome.

Mr. Hatem Akl, Chief Information Officer, reported on security concerns regarding copy machine internal hard disks. He assured the trustees that the College's IT Department takes every precaution available to protect our data on the multi-function copiers that are used, as well as laptop and desktop computer hard drives once the machines have reached the end of their useful lives.

On November 11, OCC will commemorate Veterans Day at the Veterans Memorial on the campus mall at noon. A Veterans Day Ceremony will also be held at the Southern Education Center at 10:00 a.m.

The OCC 50^{th} Anniversary holiday celebration will be held on Friday, December 5, at 6 p.m., at Jack Baker's Lobster Shanty in Point Pleasant. Tickets are \$35 and are limited.
