Existing Nursing Building	P.O. for HVAC design engineering services issued to DLB on 9/1/13. DLB will begin the Design for Mechanical RFP. FAC In-house operations will work on doors entrances, painting contractor for hallways, and air compressor all items will be on the November 4 BOT.	
Combined Heat and Power Plant (CHP):	Broad chiller commissioning is in progress. Controls system to be commissioned. Plant to begin operation in 4th quarter. Black-Start design in early stages. Several modifications are being made to comply with manufacturer requirements prior to operation. Design issues with existing buildings being investigated. Evaluated.	
County Road Project Phase II - Parking Lot 5:	Lot # 5 tree clearing complete. Sub-grade installation and Security Building (adjacent to Basin #5) tree clearing is in progress. The installing of the drainage pipe crossing College Drive was completed Friday, September 6 th . Buckwald Drive will be closed to traffic at about 7:30pm each evening. We are expecting a completion shortly. No adverse effect to student egress. County has done a phenomenal job!	
Brown Property – ADA:	In the process of upgrading property to ADA standards with the use of an approved Grant Extension by Toms River Township. A bid is in process. We should make the November BOT for approval.	
OCEAN Signs:	The electrician has set up the lights on the signs and timers to be installed soon. They look great at night. Great Job Jan Kirsten and staff.	
Instructional Bullding:	Project budget for renovation is \$11.4 M. A/E RFP bids are being reviewed. Three finalists have been interviewed. A recommendation will be included in the September Board of Trustees Meeting. Project entails major mechanical system components, classroom and laboratory renovations and the creation of a new front entrance.	



Building Numbering & Entrance Signs:	Scope will include renumbering all Campus Buildings following a new sequence protocol. In addition, all doorway signs will be replaced with an alpha identifier, and new Campus Maps will be updated. Campus Way-finder signage will also be included in the scope of this project.	
Security Break & Locker Room:	Upgrade Facilities. Lockers ordered and being shipped. In-house organization is in process of purchasing the kitchenette, floor covering and lockers for Security/Welcome Center.	
Mill Creek Sailing Center (MCSC):	Mill Creek Sailing Center project was temporarily put on hold due to lack of funds for the entire project. Our goal is to build the dock this year so that fundraising can occur to raise money to construct the building. Currently the College intends to build the dock only with minimal site work using available funds in 2013/2014. A fundraiser is planed next May for 300 people on the dock site for the overall program completion.	
Major Sidewalk Installation:	In anticipation of Campus construction projects, Facilities plans to continue the sidewalks leading from Parking Lot #2 to the back of buildings to divert pedestrians from active roadways.
