 A resolution to authorize the appropriate College officials to enter into and execute an agreement for International Higher Education Support Services from April 26, 2018, through April 26, 2020

- A \$12,500 grant award from Disability Rights New Jersey (DRNJ), to create a comprehensive service structure to be managed by the Office of Disability Services staff and supported by staff at Kean University supporting the needs of veterans, especially those identifying as disabled.
