- e. For professional engineering consulting services for water infiltration at the Technology Building at Ocean County College (Exhibit A-7)
- 4. Recommend rescission of the \$23,566 contract awarded on February 24, 2014, to Tele-Measurements, Inc., Clifton, New Jersey, for the purchase of NewTek TriCaster video editing and production equipment for use at Ocean County College; and, instead,

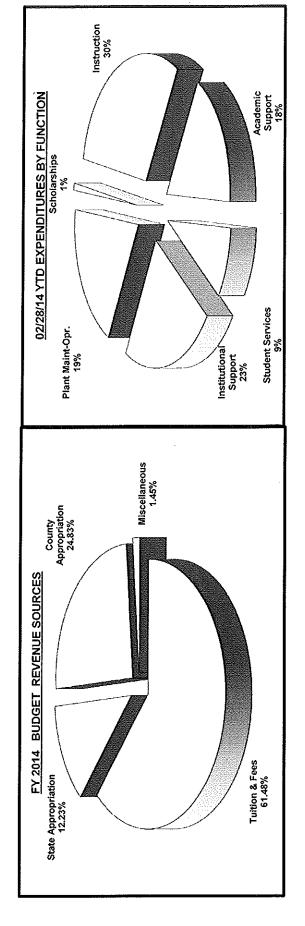

- d. An additional \$2,453.10, for a maximum total of \$31,938.10, to The College Board, New York, New York, for additional Accuplacer and diagnostic unit testing materials for use at Ocean County College (contract originally awarded at the November 4, 2013, Board meeting) (Exhibit A-14)
- 7. Recommend rejection of the bid proposal received on March 11, 2014, for Nursing software in accordance with bid specifications and requirements as a result of only one response being received, which was determined to be noncompliant (Exhibit A-15)
- 8. Recommend acceptance of a \$150,000 grant award from Santander Bank, N.A., Boston, Massachusetts, representing a gift of \$50,000 per year for three years, to support the development of the Lakewood High School Program, which will seek to increase college access and positive educational outcomes by providing academic support, workshops and seminars for students and parents, imbedded Jump Start courses, assistance with the application for college, financial tuition support, and continuing academic and personal support while attending college. Project director: Ms. Laura Rickards, Director of EOF/OMS. Project period: March 24, 2014, through June 30, 2017.

WHEREAS,	the New Jersey Council of County Colleges has requested the community college sector submit a request to release Chapter 12, Public Law 1971, Capital Facilities Projects, not to exceed \$3,200,000 for FY 2015; and
WHEREAS,	the State of New Jersey Treasurer's Office is anticipated to release Chapter 12, P.L. 1971, funds to the sector; and
WHEREAS,	the State will commit these funds on a basis of fifty percent State and matching fifty percent County formula; and
WHEREAS,	the total project cost for the construction of a new Nursing/Information Technology Building is estimated at \$16,450,000; and
WHEREAS,	the project will be funded by FY14 and FY15 Chapter 12. The balance of the project not funded by Chapter 12 will be funded by the College and the County of Ocean through a mutually beneficial agreement yet to be determined; and
WHEREAS,	the Board of Trustees of Ocean County College approved the College's Facilities Master Plan on March 8, 2013, which designated facilities improvement and construction projects;
NOW, THERE	FORE, BE IT RESOLVED that the Ocean County College Board of Trustees approves the

- WHEREAS, the New Jersey County College Joint Purchasing Consortium is composed of the membership of the county colleges in New Jersey; and
- WHEREAS, the Joint Purchasing Consortium was formed to provide an instrument for the county colleges to combine purchasing power and realize savings to benefit the participating institutions.
- WHEREAS, Ocean County College has determined it would be advantageous to combine the joint purchasing power of New Jersey's county colleges in order to obtain the best pricing for the purchase of consulting services for the procurement of natural gas.
- WHEREAS, Ocean County College has acted as Lead Agency and administered a Request for Proposals to assist the Consortium in obtaining consultant services for the procurement of natural gas to include data collection and analysis, procurement strategy and RFP development, bid process, advertisement, bid/auction, and monitoring services; and
- WHEREAS, the membership of the Joint Purchasing Consortium has reviewed all proposals received in response to the RFP and via official vote selected T & M Associates
