#### **FACILITIES MANAGEMENT AND CONSTRUCTION PROJECTS**

LOCATION / PROJECT	Latest Project Update	
CONSTRUCTION PROJECTS		
STUDENT ENROLLMENT BUILDING (SEB)	The new Student Enrollment Building project is on schedule and budget. The building is still slated to open Summer 2021. The roof installation, windows, and masonry wall work should be completed in December. Currently, the general contractor (GC) is nearly complete with interior framing while all HVAC, plumbing, fire protection, and electrical work are in progress. The building's location perfectly fits with the Student Center (#8), the Conference Center (#10), and the Grunin Center (#11).	
CONFERENCE CENTER RENOVATION	The Conference Center Building (#10) renovation project received its Temporary Certificate of Occupancy (TCO) last month. The Certification of Occupancy (CO) should be delivered this month and, due to the nature of the surrounding construction, an opening is anticipated for Spring 2021. The Design Committee met this month to formulate an interactive and passive display through photographs and written messages depicting the importance of preserving New Jersey land and water resources through education and awareness. OCC students are intended to assist with the photography.	
SECURITY ACCESS AND CAMERA UPGRADE	The Integrated Service Consulting has upgraded the College's security software with improved clarification. The installation of the Security Camera Phase III project will be completed this month. The IT and Security Departments are working on the final closeout list.	
GYM BLEACHERS UPGRADE	The existing gymnasium in the Health and Human Performance Center (HPEC) bleachers have been installed.	
GATEWAY – KEAN OFFICE RENOVATION	Construction of the new office space for Kean-Ocean within the Student Lounge area on the first floor of the Gateway Building is almost complete. The completion date is expected to be this month, pending on the delivery of doors and carpet tiles.	
SAILING CENTER	The Sailing Center project now moves to the NJDEP comprehensive review, which allows for a 90-day time-frame. The OC Park and Recreation will contribute \$500,000 to the project pending the College Opportunity Fund's approval. The completion date is 2022.	
PERFORMING ARTS ACADEMY (PAA)	The final closeout documentation and punch list corrections are nearly complete; however, Wallace has not completed the closeout requirements.  One of Wallace's subcontractors, Earle Asphalt, has filed a lawsuit against Wallace for lack of payment and has named the College. The College's insurance attorney will respond to the suit.

FACILITIES STORAGE STRUCTURE (BARN)	The Barn and site demolition is complete. Due to the pole barn manufacturer lacking NJ qualifications, an architect/engineer (A/E) has been solicited to provide a design so the GC can bid on the barn.

PROGRAMMING & DESIGN – On Hold		
ADMINISTRATION BUILDING (ADMN)	The design of the new Administration Building is complete. The design is for a three-story, 33,000 square foot building located adjacent to the Planetarium. The building will use new HVAC technology to reduce the life-cycle maintenance cost and provide optimal comfort to the building occupants. The general contractor biddings are on hold for the foreseeable future until funding is available from the NJ/OC Chapter 12. The \$8,000 permit payment to TRMUA is also on hold.	
ADMINISTRATION BUILDING – DEMOLITION MALL RENOVATION	Ocean County College wishes to increase the canopy coverage of trees to offset the demolition of the Administration Building's landscape. With a ten-year plan to create a park-like setting on the main mall, Kimmel has provided renderings and a short video.	
GRUNIN CENTER – LOBBY OPTION	Conceptual designs for a different-sized addition of the Grunin lobby was created and presented to the President's Leadership Team (PLT) for review and comments. At the right time, Dr. Larson will present to the County and possible donors. For now, this project is on hold for the foreseeable future until funding becomes available.
