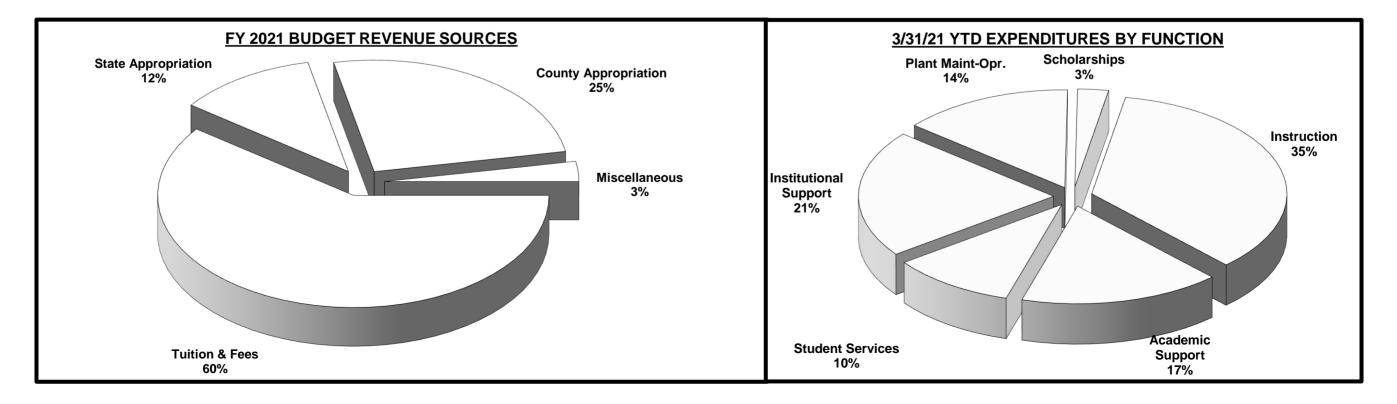

RESOLUTION

- **WHEREAS**, the U.S. Coronavirus Aid Relief and Economic Security (CARES) Act was enacted on March 27, 2020, in response to the economic damage and hardship to American states, counties, and municipalities as a result of the COVID-19 pandemic; and
- **WHEREAS**, CARES Act funds were received by the County of Ocean from the United States Treasury for reimbursement of economic damage caused by the Coronavirus to the County, its agencies, and its municipalities; and
- **WHEREAS**, the Ocean County Board of Commissioners has determined that it is in the best interests of the citizens of Ocean County to dedicate a portion of the funding to reimburse Ocean County College for COVID-related costs and expenses through the Ocean County CARES Grant program;

- **NOW, THEREFORE, BE IT RESOLVED** that the Ocean County College Board of Trustees authorizes the College to extend its agreement with the County of Ocean through December 31, 2021, to receive funding through the Ocean County CARES Grant Program and further directs the appropriate College officials to execute the agreement in compliance with the terms and conditions of the December 10, 2020, agreement, its Clarification to the Ocean County CARES Act Agreement, and its Ocean County CARES Act Agreement Addendum.
