



- c. An additional \$16,800, for a maximum total of \$717,100, to Kimmel Bogrette Architecture + Site, Inc., Blue Bell, Pennsylvania, for the modification of engineering drawings and specifications to include installation of a new boiler and chiller at the Planetarium as part of the professional architectural and engineering services for demolition of the current Administration Building and design of the new Administration Building at Ocean County College (contract originally awarded at the July 25, 2019, Board meeting) (Exhibit A-24)
- 5. Recommend adoption of a resolution to apply for a four-year (2021 to 2025) Consolidated Adult Basic Skills and Integrated English Literacy and Civics Education (Title II) grant from the New Jersey Department of Labor and Workforce Development to provide adult basic education, literacy, and English as a Second Language in order to obtain/retain employment and become self-sufficient; to support adults who desire to complete a secondary school education or industry-valued credentials; and to assist adults who are parents to obtain the skills necessary to become partners in the education of their children. Project period: July 1, 2021, to June 30, 2022. Award amount: \$693,669. Project director: Ms. Gina Opauski, Director of Community and Workforce Development.

OCEAN COUNTY COLLEGE RESOLUTION Authorizing a Contract for Athletic Training Services & Student and Employee COVID Testing

WHEREAS, a contract in the amount of **\$10,000.00** - (BPO # 10558) has been awarded to **RWJBarnabas** Health Corporate Care, 101 Prospect Street, Lakewood, NJ 08873, for Occupational Health Services at Ocean County College; and

WHEREAS, an additional amount of \$17,097.00 is needed to provide Athletic Training Services available for use by Ocean County College; and

WHEREAS, an additional amount of \$25,000.00 is needed to provide COVID testing for Nursing Students and Faculty and N95 Mask fitting medical clearance at Ocean County College. The purchase of said goods and services utilize funds allocated to Ocean County College through the Coronavirus Relief Funds (CRF), CARES Act that provides for payments to State, Local, and Tribal governments navigating the impact of the COVID-19 outbreak; and

WHEREAS, the vendor has completed and submitted a Business Entity Disclosure Certification which certifies it has not made any reportable contributions to a political or candidate committee in the County of Ocean the previous one year, and that the contract will prohibit making any reportable contributions through the term of the contract; and
