Board of Trustees Meeting Minutes

College Policy #1370 requires that amendments to bylaws be introduced at one meeting of the Board and adopted at a subsequent meeting. The trustees will review the amendments proposed; they will be recommended for formal adoption at the April 28, 2022, Board meeting.

Ms. Tracey Donaldson, Associate Vice President of Human Resources, discussed the need to revise Policy #2410, Nondiscrimination, Equal Opportunity, and Harassment, and OCC Title IX Process Manual, as well as the rescission of Policies #2420, Prohibition of Discrimination and Harassment in All Forms, and #2430, Sexual Assault. These revisions will be presented at the April 28, 2022, Board meeting. If approved, the revisions to Policy #2410 would create one clear anti-discrimination/harassment policy with two clear procedures for addressing Title IX complaints and other discrimination complaints. Ms. Donaldson thanked Dr. Gerald Racioppi, Vice President of Student Affairs, for helping to update the policies and procedures. Mr. Dasti and the Trustees commended Ms. Donaldson for the detailed presentation.
