#### RESOLUTION

#### Authorizing a Contract for Server Infrastructure Upgrade

WHEREAS, the Board of Trustees at Ocean County College recognizes the need for a comprehensive server upgrade to ensure the continued stability, capacity, and support of the existing IT environment at Ocean County College. The existing server hardware has reached end-of-life and is no longer supported by the manufacturer, posing potential risk to the college's operations. A new physical server will provide additional capacity and support to deploy new virtual servers and expand support of Virtual Desktops for employees and students. This purchase will be procured through NJEdge.NET Consortium; and

WHEREAS, the Board of Trustees of Ocean County College has a need to acquire goods and services which are exempt from bidding pursuant to the provisions N.J.S.A.18A:64A-25.10, joint purchases by county colleges, municipalities or counties; authority, permits purchases to be made through such a consortium; and

**WHEREAS**, the Executive Vice President of Finance and Administration of Ocean County College has determined and certified in writing that the value of the acquisition will exceed \$17,500.00; and

WHEREAS, in accordance with N.J.A.C. 5:30-5.4, a Certificate has been provided by the Executive Vice President of Finance and Administration of Ocean County College, stating that funds are available for this purpose, which certificate is attached to the original of this resolution and is on file in the office of the Executive Vice President of Finance and Administration; and

**WHEREAS**, Ocean County College wishes to award a fair and open contract in compliance with the provisions of N.J.S.A. 19:44A-20.4 and without the need for public bidding in compliance with the provisions of County College Contracts Law, N.J.S.A.18A:64A-25.1 et seq.;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Ocean County College, in the County of Ocean and the State of New Jersey as follows:

The Ocean County College Board of Trustees hereby authorizes and directs the appropriate officials of the College to enter into and execute an agreement with **SHI International Corp.**, 290 Davidson Avenue, Somerset, NJ 08873 in the amount not to exceed \$767,605.08 for a comprehensive server upgrade to ensure the continued stability, capacity, and support of the existing IT environment at Ocean County College. WHEREAS, additionally, staff providing direct services to the participants are required to complete three (3) mandatory trainings, which are Protection of Minors, Youth Culture/Development, and Mental Health/Substance Abuse, provided through the Ocean County Achievement Center; and

WHEREAS, these services are funded through the Work Readiness Assistance Program (WRAP) grant awarded from the Ocean County Department of Human Services, Workforce Development Board, for the Workforce and Professional Education Department at Ocean County College; and
