**1**

**All Early College and Dual Enrollment participants are considered College students**

**2**

**Accommodations are for access only**  
*“Fostering Success through Access”*

**3**

**The K-12 district, instructors, or accommodations cannot alter or modify course objectives, rigor, or content**

**4**

**College credit cannot be awarded if Dual Enrollment or Early College course content or rigor is modified**

**5**

**Accommodations must preserve academic content and integrity**

**6**

**Notify OCC Disability Services when an Early College or Dual Enrollment student with disabilities requests accommodations**
