- An additional \$9,120, for a maximum total of \$20,884.93, to Audio Visual Imagineering, Inc., Orlando, Florida, for a five-year license for the full-dome film, "The Great Solar System Adventure" for the Planetarium at Ocean County College (initial contract was under threshold and did not require Board approval)
- Recommend approval of a lease agreement with Ocean County PIC for the use of a room in the Continuing Learning Center at Ocean County College for the purpose

of offering services, including academic, career, and financial programs, as part of the Youth Career Opportunity Plan/Ocean County Achievement Center for a term of one year (July 1, 2026 to June 30, 2027).

- Recommend acceptance of \$553,649 for the Strengthening Career and Technical Education for the 21st Century Act, otherwise known as Perkins V, from the New Jersey Department of Education (NJDOE) for the 2026-2027 academic year. The purpose of this grant application is for receiving funds for developing more fully the academic, career, and technical skills of Ocean County College students through instruction, providing equipment and supplies, offering professional development for faculty and students, and curriculum assessment and accreditation, with an emphasis on curricula promoting workforce education and economic development. Project Manager: Ms. Danielle M. Jones, Program Director, Career and Academic Programs. Project Period: July 1, 2026, through June 30, 2027.
- Recommend adoption of a resolution for the Consolidated Adult Basic Skills and Integrated English Literacy and Civics Education (Title II) grant from the New Jersey Department of Labor and Workforce Development application. The program provides adult basic education, literacy, and English as a Second Language in order to obtain/retain employment and become self-sufficient; to support adults who desire to complete a secondary school education or industry-valued credentials; and to assist adults who are parents to obtain the skills necessary to become partners in the education of their children. Project period: July 1, 2026, through June 30, 2027. Award amount: \$1,001,310. Project Director: Ms. Gina Opauski, Director of Ocean County Achievement Center.
